

RIVERWIND SHILOHS SALES CONTRACT

Whereas, Deborah Mayo of Riverwind Shilohs, hereinafter called "Breeder" or "Seller" is the owner of a Shiloh Shepherd _____ further described as follows:

Whereas, _____, herein after called "Buyer" is desirous of purchasing the Shiloh Shepherd described above.

Now, therefore, in consideration of the sum of \$ _____ dollars, the seller conveys the above described Shiloh Shepherd to buyer under the following warranties and conditions and no other warranties or conditions are either expressed or implied:

1. The prefix or suffix "Riverwind" is required in permanently registering this canine with I.S.S.R. If not, this guarantee is null and void.
2. The above described canine is purebred and registerable with the I.S.S.R. and the pedigree is true and correct to the best of the Seller's knowledge.
3. The above described canine is guaranteed for 48 hours to be in good health and free of communicable diseases at the time of sale as diagnosed by a licensed veterinarian.
4. The above described canine is guaranteed to one (1) year of age against any genetic defect, confirmed by necropsy conducted by a Veterinary pathologist; that arises causing termination of life. This specifically excludes internal and external parasites. Seller retains the right to choose replacement puppy, applying equal financial value to new puppy, after confirmation that conditions of claim exists.
5. The above described canine is guaranteed against crippling hip dysplasia as certified by PennHip at the age of two (2) years. This specifically excludes dysplasia caused by environmental factors or buyer mishandling. The dog will stay placed with Buyer and decision on how to handle the hip dysplasia will be by the owner and their veterinarian at Buyers cost. Seller retains the right to choose replacement puppy, applying equal financial value to new puppy, after confirmation that conditions of claim exists.
6. All medical bills and otherwise incurred expenses of showing or training remain the responsibility of the Buyer.
7. Any canine sold under this agreement will not be chained, or tied. Violation of this can result in confiscation of the above described dog/bitch. The purchaser also agrees to keep this dog/bitch for as long as he/she lives, unless unforeseen circumstances arise. Should the purchaser not be able to care for this dog/bitch, the Breeder must be notified first and given first option to reclaim the dog/bitch at no charge. This dog/bitch may not be placed in another home without the written consent of the Breeder. The canine may not be registered with any other registry other than the I.S.S.R.

8. The Buyer is encouraged to follow basic feeding guidelines of the Seller. This is to help guarantee the overall continuing health of the canine.
9. The Buyer must hip x-ray PennHip (PennHip certified Veterinarians can be found at www.Pennhip.org) between 12 to 14 months of age and **send copies of report** to Riverwind Shilohs.
10. This contract is not transferable and constitutes the full agreement of the parties.
11. Deposits or prepayments are non-refundable, but can be applied for up to three years towards the purchase of a Riverwind Shilohs puppy (or adult).
12. No personal checks will be accepted unless presented prior to 14 days of scheduled "shipment" or "pickup" of puppy. Recommended payment is money order, bank transfer, or Paypal to riverwindshilohs@sbcglobal.net (with a 3% charge of amount being transferred through Paypal added to total). Under no circumstances will a puppy be released without full payment.
13. Puppy placement calls will take place the morning following the litter evaluation (6:00 a.m. to 12:00 noon Central time zone). It is the Buyer's responsibility to give Breeder a contact number to reach them at. The earliest puppies will be available for pick-up or shipping after 12:00 noon the day following the litter evaluation. Picking up and shipping puppies to their new homes will take place within a consecutive three day period following the litter evaluation. Should Buyer not be able to receive their puppy within that window a \$25 a day board fee will be charged and arrangements for this must take place prior to the litter evaluation. Buyer will be notified of the litter evaluation dates at least one month prior to the litter evaluation to have time in which to make appropriate arrangements for receiving their puppy.
14. Shipping: Shipping fees are \$250.00, plus actual cost of airfare (\$250.00 covers airline approved shipping crate and shipping materials, ISO compliant micro chip, first round of vaccinations, de-worming, Veterinary Health Certificate, and transportation to airport). Puppies will be sent COD to Buyer, so that Buyer will incur actual airfare costs to their destination.
15. Puppy pickup fee is \$75 (covers ISO micro chipping, first round of vaccinations and de-worming) for those picking up their puppy at Riverwind Shilohs.
16. Pet quality puppies sold to residents residing in the state of Oklahoma will be charged 8.375% sales tax (or current rate) as mandated by Oklahoma State.
17. All puppies receive first round of vaccinations, micro chipping, health certificate (if shipping), and de-worming, included in shipping and puppy pickup fees.
18. All pet puppies must be spayed or neutered at buyer's expense.
